



Language Matters

- CCTS uses person-first language (person with a disability)
- Some individuals/populations prefer disability/identity-first language (disabled person)
- Listen to how individuals self-identify and take your cues from them.





Why and How: Post-School Outcome Data Collection



Federal Collection and Reporting

Purpose Requirement To determine how well states are meeting their responsibilities under the Individuals with Disabilities Education Act (IDEA)

All states collect data on 17 **IDEA** performance indicators

Findings are reported to the **Office of Special Education** Programs (OSEP)



Post-School Survey Logistics



Survey is open June 1-November 1 each year



Surveys are conducted over the phone by school/school district representatives



Survey questions are answered by former special education students ("leavers"), one year after exiting high school



Survey data are reviewed, analyzed, and reported by CCTS



Leaver Criteria for 2022 Survey

- All former students who exited school in the 2020-21 year and were receiving special education services
- Age 16-21 with active IEPs at the time of exit
 - Aged out
 - Dropped out
 - Graduated with a diploma
 - Expected to return but did not



Data Matters

How can post-school outcome data inform our work in transition?



What can the data tell us?

- Of my students/clients, who is engaged after leaving high school?
 - What do we know about these former students?
- Who isn't engaged?
 - By what disability category?
 - Race/ethnicity?
 - Gender?
- Do state data reflect the data in my county? Why or why not?
- What might help our students to be as prepared as possible for life after high school?

Launching into the Data


- Be curious and ask questions
- Compare demographic data
- Compare state, ESD, county, and district-level data
- Look at individual surveys
- Look at the data with a team or partner












Engagement Outcomes by Exit Categories, 2020-21 Washington state graphs (1 of 2)






Engagement Outcomes by Gender Categories, 2020-21 Washington state graphs (1 of 2)
















